-- in the event that the client's guardian is granting the consent – the following documents shall be attached: documents that attest that he has been lawfully appointed as the client's guardian and documents that specify which powers he has by virtue of this appointment;

-- in the event that the attorney-in-fact pursuant to the Legal Capacity and Guardianship Law, 5722 - 1962 is granting the consent – the following documents shall be attached: a copy of the continuing Power of Attorney that was prepared pursuant to Section 32(M) of the aforesaid law, confirmation of the appointment of the Administrator General pursuant to Section 32(Q) of the aforesaid law, and confirmation of receipt of notice of the taking of effect thereof pursuant to Section 32(S) of the said law, and a declaration by the attorney-in-fact that the Power of Attorney is in effect.
